

**American Airlines Federal Credit Union  
“20<sup>th</sup> Credit Card Anniversary” Drawing  
Official Rules**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS DRAWING. PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS DRAWING IS INTENDED FOR VIEWING IN THE UNITED STATES ONLY AND SHALL ONLY BE CONSTRUED AND EVALUATED ACCORDING TO UNITED STATES LAW. VOID WHERE PROHIBITED.**

**I. DRAWING PERIOD:** The **20<sup>th</sup> Credit Card Anniversary** (the “Drawing”) begins at 12:00:00 a.m. midnight Central Time (“CT”) on 10/01/2024 and ends at 11:59:59 p.m. CT on 12/31/2024 (the “Promotion Period”). The Drawing is sponsored by American Airlines Federal Credit Union (“Credit Union”), MD 2100, PO Box 619001, DFW Airport, TX 75261-9001 (the “Sponsor”). The official clock for purposes of the Drawing is the computer of the Sponsor.

**II. ELIGIBILITY:** The Drawing is open to all legal consumer residents of the fifty (50) United States and Washington DC who are Credit Union members in good standing and who are eighteen (18) years of age or older. Officers, contractors, directors, officials, committee members, representatives, agents, family members of employees of the Sponsor, and employees of the Sponsor; and those of Sponsor’s respective parent companies, affiliates, franchisees, licensees, subsidiaries, and advertising/promotion agencies, and persons engaged in the development, production or distribution of materials for this Drawing (collectively, the “Released Parties”) are not eligible to participate in the Drawing. The Drawing is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's (also referred to as “Participant,” “you,” and “your”) full and unconditional agreement to these Official Rules and Sponsor decisions, which are final and binding in all matters related to the Drawing. Winning a prize is contingent upon fulfilling all requirements listed below. **Void in Puerto Rico, the U.S. Virgin Islands, Guam, U.S. Military installations in foreign countries and where prohibited, taxed or restricted by law.**

**III. HOW TO ENTER THE DRAWING:** An individual will be deemed a Participant in the Drawing if the individual uses their Credit Union credit card to make purchases during the Promotion Period or enters by the alternative method. The purchase of cash instruments such as cashier’s checks, making wire transfers or online transfers, obtaining cash advances, or gambling using your credit card does not qualify for this Drawing.

To Enter: There are two ways to enter the Drawing. First, during the Promotion Period, use your Credit Union credit card to make purchases. Every one (1) purchase, convenience check or balance transfer to your Credit Union credit card that posts to your account during the Promotion Period will give you one (1) entry

in the Drawing, up to a maximum of 2,000 entries. Total purchases will be tallied by Sponsor and will be net of refunds and/or returns.

You may also enter by sending a 3 X 5 note card with your complete name, address, city, state, zip code, phone number and valid email address to the following address, which must be postmarked (by U.S.P.S.) no later than 11:59 p.m. CT on 12/31/2024. Limit to a total of twenty-two (22) mailed-in entries per day for the Promotion Period. Each mailed in entry must be mailed separately. A Participant is eligible to win only one one thousand U.S. dollar (\$1,000.00) prize in the Drawing. Of the one thousand U.S. dollar (\$1,000.00) prize winners, one will be randomly selected to win a grand prize of twenty thousand U.S. dollars (\$20,000.00) based on net purchases during the promotion period. All required information must be completed to enter and to be eligible to win. Incomplete entries will be disqualified. Sponsor reserves the right, in its sole discretion, to void any and all entries of a Participant that submits more than the stated maximum limit of entries by using multiple/different addresses, identities or any other methods, or whom Sponsor believes has attempted to tamper with, influence or impair the administration, security, fairness or proper play of this Drawing. Proof of entering information is not considered proof of delivery to or receipt by Sponsor of an entry. The use of automated entry devices is prohibited and no mechanically reproduced entries are allowed; all such entries are void. Released Parties are not responsible for lost, late, stolen, incomplete, illegible, incorrect, damaged, delayed, garbled, undelivered, postage-due, or misdirected entries, which will be disqualified. All entries become the exclusive property of Sponsor and will not be acknowledged or returned.

**IV. PERSONAL INFORMATION/OPT-IN:** Participants are providing their information to Sponsor and not to any other entity. By entering the Drawing, you consent for the Sponsor to obtain and use your name, address and other information (“Personal Information”) for the purpose of administering this Drawing and such Personal Information will be kept by Sponsor for marketing purposes in accordance with its privacy policy ([www.aacreditunion.org/globalassets/documents/privacy-notice.pdf](http://www.aacreditunion.org/globalassets/documents/privacy-notice.pdf)), as posted on our website at [www.aacreditunion.org](http://www.aacreditunion.org) (“Website”). The information that you provide in connection with the entry process will be used by Sponsor only. You will remain eligible for this Drawing whether or not you opt-in to receive promotional emails from the Sponsor and will have the ability to opt-out of receiving future promotional emails by clicking on the link contained in the most recent promotional email received.

**V. PRIZES:** There will be twenty-one (21) prizes available to be awarded for this Drawing. Twenty (20) Prize Winners will receive One Thousand U.S. dollars

(\$1,000.00) to be deposited into their Credit Union primary share account (S0000) approximately 10 days after the Prize Winners have been confirmed. One of the twenty \$1,000 prize winners will receive Twenty Thousand U.S. dollars (\$20,000) to be deposited into their Credit Union primary share account (S0000) approximately 10 days after the Prize Winner has been confirmed. The total prize amounts to be awarded is Forty Thousand U.S. dollars (\$40,000.00). In accordance with IRS Rules, the value of each prize may be treated as income to the winner, and the winner may be responsible for reporting of income and payment of all applicable federal, state, and local taxes. If applicable, an IRS Form 1099 will be issued to each Prize Winner for the total amount of the prize in the calendar year the prize was won. If the prize is merchandise, the stated "ARV" of the prize is based on available information provided to Sponsor and any difference in ARV at the time of awarding will not be awarded

**VI. PRIZE WINNER SELECTION:** Odds of winning a prize will depend on the total number of eligible entries received. Twenty (20) Prize Winners will be randomly selected from all valid entries received, and then one (1) prize winner from the twenty (20) prize winners for the grand prize. The Drawing will be conducted at the Credit Union's Headquarters in Ft. Worth, Texas, at the close of business on 11/15/2024, 12/15/2024, 01/15/2025, and the grand prize on 02/15/2025. Need not be present to win. Winner will be notified by phone, email, or mail. If a winner cannot be contacted within five (5) business days of the initial contact date, the prize will be forfeited and awarded to an alternate winner. Upon initial notification and verification of each Prize Winner, confirmation will be sent to the Prize Winner via email, USPS mail or other home delivery service of Sponsor's choice.

**VII. PRIZE TERMS AND CONDITIONS:** All properly claimed prizes will be awarded. Each Prize Winner may be required to provide additional documentation and is required to comply with any and all applicable federal, state and local laws, rules and regulations. Except as prohibited by applicable law, each Prize Winner will be required to sign an Affidavit of Eligibility and Liability/Publicity Release and provide valid identification (collectively, the "Prize Acceptance Release"), and return it within five (5) business days of written notification or the prize will be forfeited and an alternate potential winner selected. If a prize or prize notification is returned as unclaimed or undeliverable to a potential winner, if potential winner fails to return requisite documentation within the specified time period, or if a potential winner is not in compliance with these Official Rules, then such potential winner shall be disqualified and an alternate winner will be selected for the prize at issue. To claim a prize, each Prize Winner will be required to provide his or her first name, last name, mailing address, telephone number and email address. Each potential winner may be subject to verification of eligibility before a prize will be awarded.

**VIII. GENERAL CONDITIONS:** If for any reason this Drawing is not capable of running as planned for any reason, including without limitation, due to infection by computer virus, worms, bugs, tampering, unauthorized intervention, fraud, technical failures, fire, flood, storm, or other natural disaster, pandemic, riot, strike, civil commotion, government regulation, or any other causes beyond the control of the Sponsor which corrupts or affects the administration, security, fairness, integrity or proper conduct of this Drawing (or any part of it), the Sponsor reserves the right, in its sole discretion, to terminate, modify, or suspend the Drawing in whole or in part at any time, without notice, and to disqualify any individual who tampers with the entry process and award the prize(s) using all non-suspect eligible entries received as of or after (if applicable) the termination or suspension date and Sponsor shall have no further liability or obligation to any Participant in connection with the Drawing. Any person who supplies false information, obtains entries by fraudulent means or is otherwise determined to be in violation of these Official Rules in an attempt to obtain any prize will forfeit any prize won and may be prosecuted to the full extent of the law. **X. GOVERNING LAW/DISPUTES:** Except where prohibited, Participant and Prize Winners agree that: (1) any and all disputes, claims and causes of action arising out of or connected with this Drawing or any prize awarded shall be resolved individually, without resort to any form of class action, and any judicial proceeding shall take place in a federal or state court in the County of Tarrant, Texas; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Drawing, but in no event shall costs incurred include attorneys' or legal fees; and (3) under no circumstances may Participant obtain awards for, and Participant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the Participants, Prize Winners, Sponsor or its affiliates, designees, or assigns in connection with the Drawing, shall be governed by, and construed in accordance with, the laws of the State of Texas without giving effect to any choice of law or conflict of law rules (whether of the State of Texas or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Texas. If any provision of these Official Rules or any other agreement or document used in connection with this Drawing is declared illegal, null, void, or unenforceable as against public policy by a court of competent jurisdiction, the remaining provisions shall not be affected.
